## Narrative

On 12/27/2025 at approximately 1524 hours, I, Officer C. Newman, 1103, of the Manitou Springs Police Department and duly sworn deputy of the El Paso County Sheriff's Office, was dispatched to the 800 block of Manitou Ave., in the City of Manitou Springs, County of El Paso, State of Colorado, for an assault in progress. Call screen notes indicated that a man spit in the reporting party's face. Call screen notes further indicated the victim was wearing a body camera.

Upon arrival, I was flagged down by an older white male party wearing a billboard around his neck. When I contacted the male party, he verbally identified himself, later positively identified in NCIC/CCIC databases, as **Stephen Scaer** **DOB:** XXXXXXXX. Stephen said that he was standing on the sidewalk with his billboard on his neck when a white male walked up to him and spit on him.

Stephen described the white male being approximately 20 years old with brown hair, wearing a black jacket. Stephen said that the white male did not say anything before he spit on him. Stephen said the white male then walked away while he followed him and called 911. Stephen said the white male walked into an alley and he lost sight of him. Stephen said he had camera footage of the incident on his body camera.

While speaking with Stephen, I asked if I could watch and record the video footage, to which he agreed. In the video footage, I observed the date was 12/28/2025 and had a time of approximately 0426 hours. I observed the camera was facing towards 814 Manitou Ave. While watching the footage, I heard what sounded like a person spit. I observed the camera turned towards a white male approximately 25 years old with brown curly hair and a mustache, wearing a black jacket and black pants. I observed in the video Stephen says, "That's assault."

I observed in the video footage the white male with black jacket responded by saying, "Ok." I observed the white

male with the black jacket then walked away from Stephen. I observed in the video Stephen walking after the male party and was blocked by another white male wearing a black jacket. I observed in the video the suspect was met by a white female with brown hair wearing a black jacket and blue jeans.

While I was speaking with Stephen, I observed what appeared to be spittle on his glasses and jacket. I asked if I could take photos of him, to which he agreed. I took photos of Stephen and observed there appeared to be a clear frothy substance consistent with spittle on his glasses and the front and back of his jacket.

Officers checked the area for the suspect but were unable to locate them. I uploaded the photos taken on scene into the attachments tab of this report. At approximately 1919 hours, I received a YouTube link from Stephen of the incident, which I recorded and uploaded into evidence.com underneath this case number. At the time of this report, further follow up was pending identification of the suspect. Nothing further.
