

Findings

Summary. Jessica Killin announced her campaign for Colorado's 5th Congressional District in July 2025, presenting herself as a Colorado Springs resident ready to fight for the district. But a review of publicly available campaign finance records raises serious questions about her residency in Colorado, commitment to the district, and why endorsements from Colorado candidates followed contributions.

Findings:

She Moved Away 25 Years Ago. Killin graduated high school in Falcon more than 25 years ago and has not lived in the district since. The community she is now asking to represent is one she left as a teenager and did not return to until a congressional seat became available.

Killin and Her Husband Recently Listed Their Address as Maryland. FEC records show Killin and her husband, Rajeev (Raj) Date, listing their Chevy Chase, Maryland, as their address for contributions as recently as October 2025 [1] and January 2026 [2], respectively. At least two months prior she claimed Colorado as her home [3], likely for political purposes. Importantly, donors self-certify their address information under penalty of law. It remains unclear which is her actual residence.

Her Husband Switches Addresses at Convenient Times. Jessica's husband, a managing partner at the venture capital firm Fenway Summer LLC, lists their Maryland residence on campaign contributions when it is optically convenient. Specifically, he has only used the Colorado address for contributions to the DCCC and DSCC [2]. He also never donated to the DCCC prior to the campaign launch, despite large prior donations to the DSCC. It is unclear whether this was to curry favor.

Her Husband Was Not Registered to Vote in Colorado Until January 2026. Rajeev had not registered to vote in Colorado until January 21, 2026 [4]. Jessica appears to have an anonymized registration, so her exact registration date cannot be confirmed. However, given Rajeev's and their donation addresses, questions can certainly be raised.

Endorsements Followed Contributions. Of the six Colorado-recipient campaigns Killin donated to around the time of her launch [5], four have since endorsed her candidacy: Senator Michael Bennet, Representative Brittany Pettersen, State Representative Amy Paschal and former Colorado Springs City Council member Yolanda Avila.
